TREASURER'S REPORT

In 2024, Steere House remained focused on advancing its mission through strong census management, high-quality care, and steadfast support of our dedicated staff. These core priorities helped ensure another year of financial strength and operational stability. A major highlight of the year was the strategic sale of our 50% equity investment in Ocean State Assisted Living. This transaction, completed in partnership with the unrelated third-party owner of the remaining 50%, resulted in proceeds of \$2,717,850 to Steere House and a recognized gain of \$1,286,273. A portion of these gains was used to support day-to-day operations, while the majority was reinvested into our endowment account, which continues to perform well and grow steadily, even in challenging economic conditions. Additionally, Steere House was fortunate to be awarded nearly \$200,000 in grant funding. These funds were invested directly into upgrading our nurse call light system and building management systems to enhance the daily experience and safety of our residents, staff, and visitors. These upgrades are a testament to our ongoing commitment to providing a high standard of care in a well maintained, modern environment. We are proud of the thoughtful stewardship and collaboration that contributed to these successes and are deeply grateful to our team, partners, and supporters for their continued dedication to the mission and future of Steere House.

The total net operating revenue for Medicare, Medicaid, and commercial insurances, and private pay residents was \$ 14,400,510 compared to operating expenses of \$ 17,433,802 for an operating loss of \$ 1,481,837 (This compares to a 2023 operating gain of \$ 443,245). However, the other income of \$ 3,233,728 which included a net investment gain of \$ 1,286,273, contribution income of \$ 385,328, grant revenue of \$ 180,539, and misc.income of \$ 53,702, unrealized and contributed property loss of \$31,046 resulted in a net loss of \$ 226,610 in 2024 compared to a net gain of \$ 443,245 in 2023.

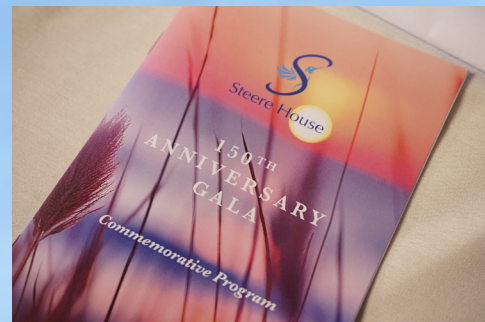
